6. Visitors/Speakers to Address the Board: None
7. Treasurers Report: **Bill Beckman made a motion to approve the Treasurers report, Dan Brodigan seconded, motion carried.**
8. Zoning Report: Larry reported building permit number 1268 was issued to Wayne Reed at 2630 County 6 to build an addition to his house with a garage. Permit number 1269 Douglas Goede at 1990 Forster Road to build a 30X36 garage and permit number 1270 was issued to Jay & Kari Ellingson at 1807 Crescent Hills Dr. to replace their driveway. Larry reported he inspected the house at 1490 County 6 and he was told by the property owner that it would be cleaned up by the end of July and it far from being done. Board directed Larry to contact our township attorney and have him draft a letter to the owner.

The Planning Commission met August 3<sup>rd</sup> and discussion was held on the residence at 745 4<sup>th</sup> St. N. The city of La Crescent attorney sent a letter of request for the Township to take corrective action to ensure the house is not a threat to the public. Larry and Bob have been to the residence and the house is in need a major repair, the septic appears to be running over and they have unregistered vehicles. Larry provided pictures to the board. Houston County Social Services and the Houston County Sheriffs department have been contacted. Bob added there are a lot of people involved at this point.

Bob reported Shawn Dunlap has agreed to serve on the board of adjustment. **Bill Beckman made a motion to accept Shawn Dunlap to the board of adjustment, Dan Brodigan seconded, motion carried.**

9. Clerk Report: Karen reported Wieser Park has been busy with park reservations. The board also received notification from the Minnesota Office of Administrative Hearings that the Earl Seaton property has been approved for annexation into the City.

11. Supervisors Report: Bill reported he put a new battery in the pickup and then it needed its brakes fixed. Bob advised the board needs to appoint a Co-Chair in his absence. **Bill Beckman made a motion to appoint Dan Brodigan as Co-Chair, Bob Cummings seconded, motion passed.** Dan no report this month.
