Chairman Bob Cummings called the April monthly meeting to order at 7:00 PM. The Pledge of Allegiance was recited by all present. Clerk Schuldt took the roll call.

4. Approval of Agenda: **Bill Beckman made a motion to approve the agenda as presented, Dan Brodigan seconded, motion carried.**

6. Visitors/Speakers to Address the Board: Brian Jervis from AcenTek addressed the board that they are planning their third and final year on the fiber to home project for the La Crescent exchange. They are starting on where County 6 and 25 meet and will work their way West on County Road 6 to the exchange. Brian presented a copy of the prints to the board. The project should be started around June and end in mid September.

That property is in Mound Prairie Twp but they also have a parcel in La Crescent Township. Mr. Frank was questioning as a curiosity if residence within a quarter mile in La Crescent Township should be notified. The feeling of the board was to have the County mail out the notices. Larry read the minutes from the Planning Commission meeting on

April 4<sup>th</sup>.
