Mr. Murphy advised what they are asking is if the board has some reasonable restrictions that it wants to place on it to grant the permit with some reasonable restrictions. Discussion was held on the door size and the parking of commercial vehicles. Following further discussion: **Dan Brodigan made a motion to allow a 14ft door but no commercial vehicles are allowed, Tom Tornstrom seconded, motion carried.**

A. Permits issued: Permit number1325 was issued to Mark Anderson at 1280 Hwy 16 to install a septic holding tank. Permit Number 1328 was issued to Jen Brabbit at 1577 Crescent Hills Drive to replace sewer system with a mound system. Bob C. reported the Planning Commission met and in attendance was a young couple who are looking into purchasing the Heberlein property. They were directed to come to the meeting tonight.
